Chiyoda Corporation agree MOU with Singaporean companies toward a sustainable hydrogen economy in Singapore

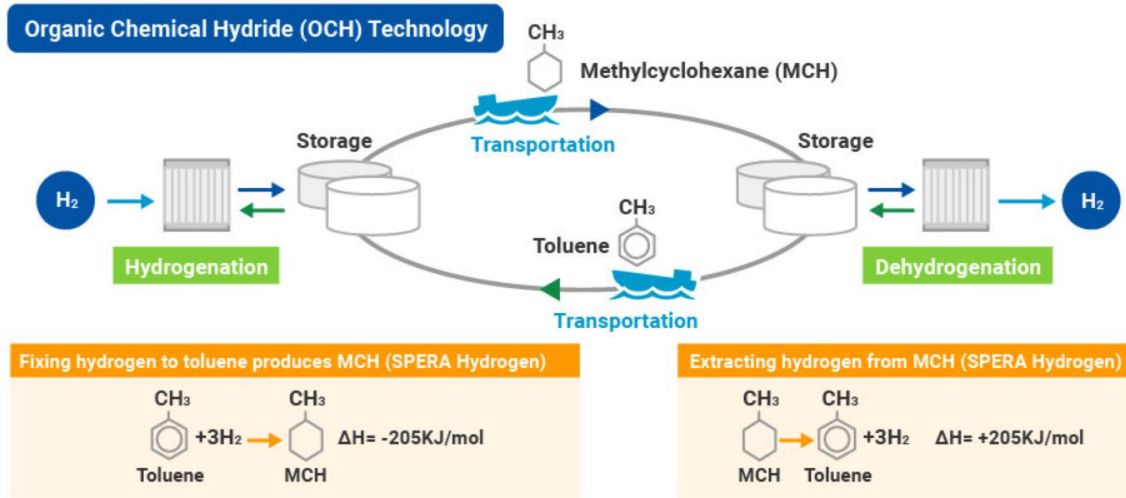
On 30 March 2020, Chiyoda Corporation is pleased to announce that it has entered into an MOU with 5 Singaporean companies, City Gas Pte Ltd, Jurong Port Pte Ltd, PSA International Pte Ltd, Sembcorp Industries Ltd, Singapore LNG Corporation Pte Ltd, together with Mitsubishi Corporation, under the witness of Singapore government, to collaborate toward a sustainable hydrogen economy in Singapore.

Singapore's government has announced its Long-Term Low-Emissions Development Strategy (LEDS), which aspires to halve emissions from 2030 peak, to 33 Million tonnes of carbon dioxide equivalent by 2050, with a view to achieving net-zero emissions as soon as viable in the second half of the century. One of the key thrust to realise the LEDS is drawing on emerging low-carbon technologies, such as low-carbon hydrogen. This also forms a key switch in the Singapore's Energy Story towards a clean, affordable and more reliable energy future.

Chiyoda's hydrogen storage and transportation technology (hereinafter referred to as "SPERA Hydrogen") could play an important role. Parties, which have strong interests and would like to contribute to the idea, have been invited to discuss the commercial and technical opportunities to utilize SPERA Hydrogen from October 2019.

Working closely with Chiyoda, a key technology and supply chain solution partner, the companies will identify and demonstrate use cases using Chiyoda's SPERA Hydrogen, Liquid Organic Hydrogen Carrier (LOHC) technology to allow hydrogen to be safely transported in chemical tankers at normal atmospheric temperature and pressure. Mitsubishi will support this development as the main shareholder of Chiyoda. The five local companies will collaborate closely with these two key partners to evaluate the technical and commercial feasibility of hydrogen usage, to develop business for hydrogen import and utilization in Singapore.
