# Chiyoda Establishes Solar Power Joint Venture

Chiyoda Corporation (Head Office: Yokohama-shi, President & CEO: Takashi Kubota) and a partner (a wholly owned subsidiary of Saibugas Co., Ltd., Japanese name is "ENESHIIDO K.K." hereafter called "ENESHIIDO"), announce that they have today established a joint venture – (Head office: Hakata-ku, Fukuoka-shi; President: Toshiaki Inaba; Japanese name is "ENESHIIDO NOK K.K." hereafter called "ENESHIIDO NOK"). The purpose of this establishment is for the two parties to jointly operate solar power generation facilities and develop a new business field.

ENESHIIDO K.K. was founded on April 2 this year to seek for a renewable energy business, with the aims of contributing to energy security through decentralization and diversification, and reducing the burden on the environment.

Chiyoda, a company whose corporate philosophy is "Energy and Environment in Harmony", enters this joint venture to further broaden its experience in solar energy following the EPC (engineering, procurement and construction) work for solar power generation facilities in Miyazaki (2MW).

As a leader in energy technologies, Chiyoda will use this opportunity to expand its businesses into renewable energy, bolster its new business of introducing new technology and accumulate knowhow in solar energy through the operation of solar power generation facilities.

ENESHIIDO NOK will operate the solar power generation facilities at three premises of the Saibu Gas Group: Nagasaki Works (Nagasaki-shi, Nagasaki), Kitakyushu Works (Wakamatsu-ku, Kitakyushu-shi) and Omuta Works (Omuta-shi, Fukuoka).
